- 2) G.Tech Pte Ltd will inform you when the GIRO is approved and the effective date. Continue paying by cash or cheque for all your season parking fees until your GIRO arrangement is effected, which takes at most 21 working days.
- 3) Deduction from your bank account will be made as follows:
Quarterly Parking Fee
 - i. **18th** before the commencement of the quarter e.g Payment for Feb 2014 to Apr 2014 will be deducted on **18th** of Jan 2014. No administration fee will be charged.
 - ii. However should the rate of deduction fall on Saturday, Sunday or Public Holiday, deduction will be made on a prior working day.

If the first deduction fails, the second deduction will be on the 25th day of the current month and there will be a service fee of \$30.00 imposed for any unsuccessful deductions.

- 4) We will inform you to pay by other ways if there are insufficient funds in your bank account. However, you should still maintain sufficient funds in your bank account for the subsequent due date. We will terminate your GIRO if we are unable to make GIRO deductions after 2 consecutive attempts. Please note that some banks do charge a service fee for unsuccessful GIRO deduction due to insufficient funds.
- 5) You may stop your GIRO payment by calling us at 6487-7421 or email to info@gtech.com.sg. But you will need to give us at least 1 month notice before the next deduction date, if not we will continue to debit your account.
- 6) You should review all your GIRO arrangement periodically and terminate those arrangements that are no longer required with your bank by completing the necessary termination forms.
