TERMS & CONDITIONS OF SEASON PARKING

The Season passholder (hereinafter described as the 'Licensee') in purchasing the season parking agrees to become the Licensee of the Company under the following terms and conditions:-

1. The Licensee acknowledges that the parking of the vehicle is at his own risk. Each of the Landlord, Property Manager, and the Car Park Management, G. Tech Pte Ltd shall not be liable for any loss, damage, theft, or misdemeanor whilst the vehicle is parked at the car park.
2. Upon the submission of this application, the Licensee shall agree and consent to the Company collecting, using, disclosing, and sharing of his/her Personal Data, including disclosing of any relevant data to the Companies' authorized service providers, subsidiaries, and vendors they work with, in addition to industry regulators, financial institutions and government organizations as required by local laws and regulations.
3. Parking fees are to be paid in advance on or by the 23rd of the previous period. This also applies to the renewal of season parking. No extension will be granted thereafter and all-season parking applications and renewals are subject to the availability of the car park lots on a first-come-first-serve basis.
4. All-season parking is issued for a specific vehicle and is strictly non-transferable.
5. All local and Malaysia vehicles are advised to install a vehicle's IU in order to apply for season parking. There shall be no sales of the season to any vehicle without the vehicle's IU.
6. Should any vehicle registration number be different from the one given to the Company, the vehicle may be treated as non-season parking and parking fees will be charged according to the casual parking rates.
7. The Licensee must notify the Company of any change in the vehicle registration number, at least three (3) days in advance. Otherwise, hourly charges will apply.
8. Should the Licensee wish to terminate his season parking, one month's notice in writing to the Company is required. Refunds will not be pro-rated and No refund will be applicable for an unexpired parking period in the event of early termination without giving the appropriate notice.
9. Application for the refund will not be entertained if received after the date of termination of season parking.
10. Should the Licensee wish to postpone his season parking for a period of not less than two calendar months without charge (maternity leave only), a written request must be made to the Company. The Company reserves the right to reject to terminate the season parking license should the Licensee fail to recommence parking on the date specified or fail to request for any extension thereof prior to this date with the Company.
11. Our Company reserves the absolute right to reject the sale of season parking to any party and to terminate the season parking previously given without assigning any reason whatsoever.
12. The Company reserves the right to withdraw the conditional lots by giving one month's notice.
13. The Company reserves the right to increase the season parking fee by giving one month's notice to the Licensee at any time during the term of the license subject to the landlord's approval.
14. The Company reserves the right to alter or amend any of the above terms and conditions
